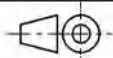

Photocurrent vs. Irradiance:

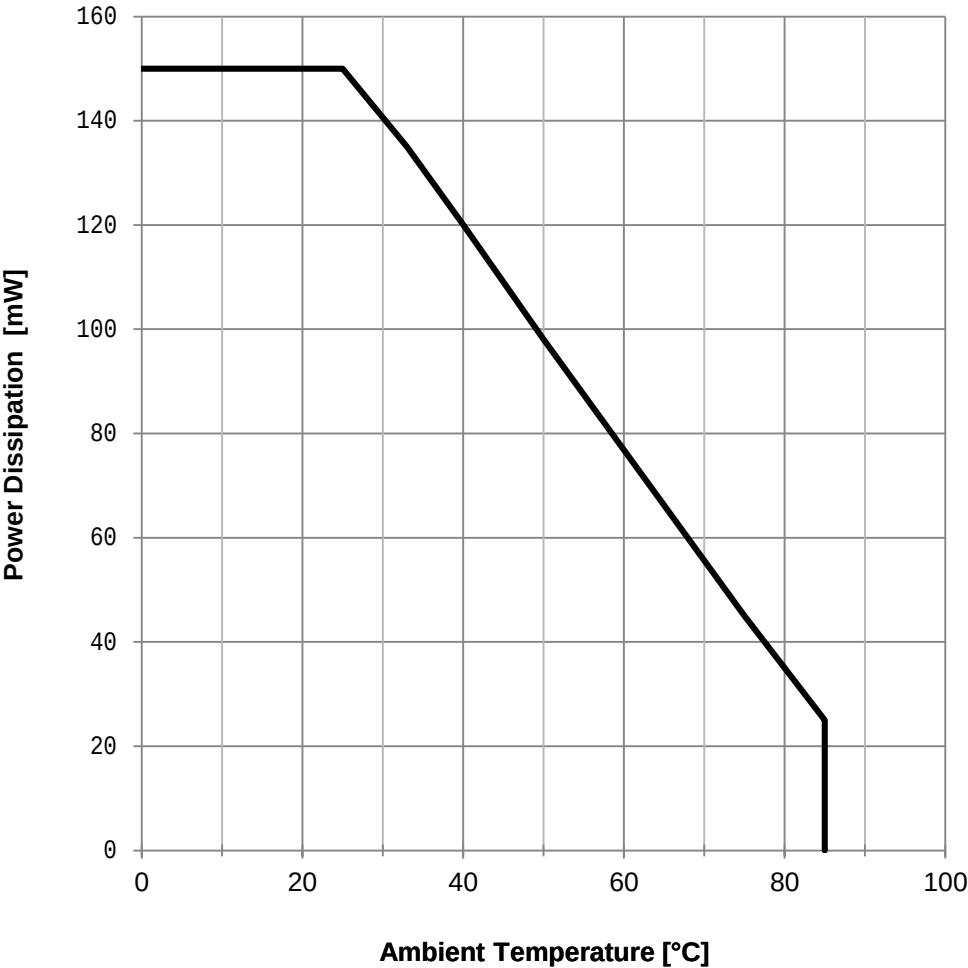

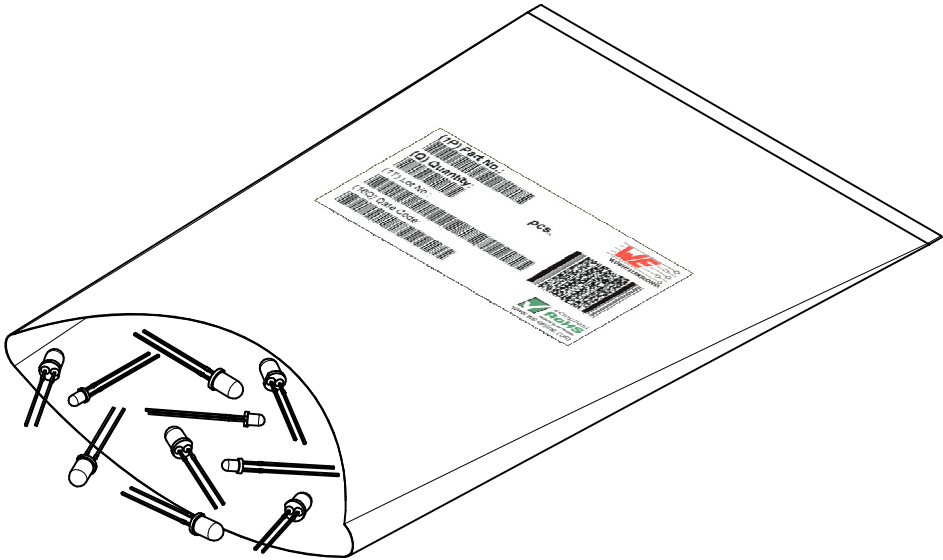
Derating Curve:

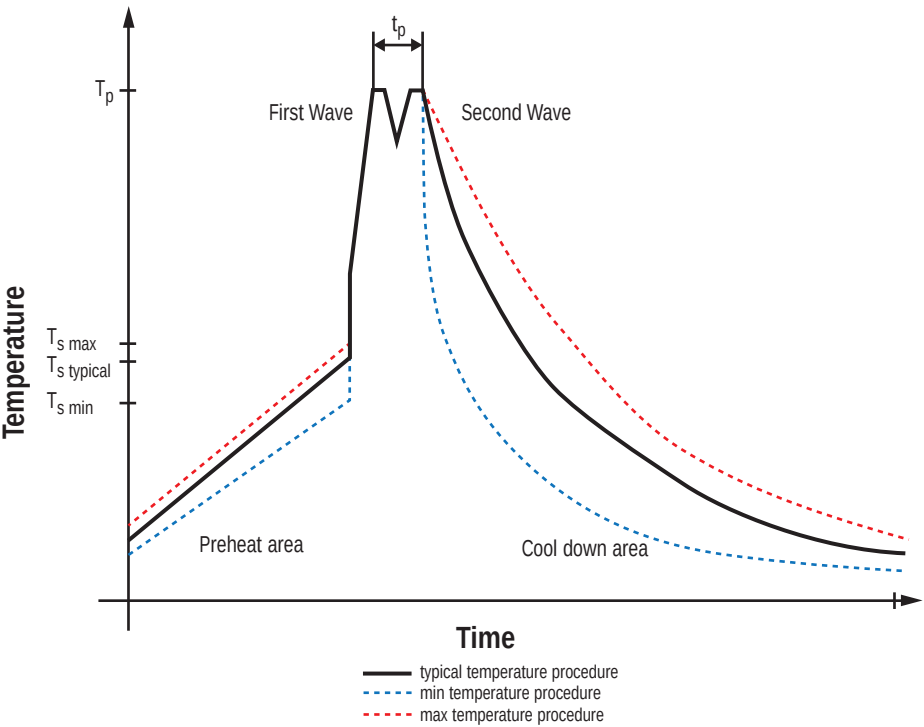

Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.
- The soldering pad pattern shown above is a general recommendation for the easy assembly of the optoelectronic component. If a high degree of precision is required for the selected application (i.e. high density assembly), the customer must ensure that the soldering pad pattern is optimized accordingly.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the optoelectronic component body, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Handling:

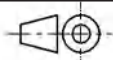

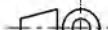
